The CSE-PPT shall have a full public offering in 2023 such that said examination shall be open to the general public, including employees from various government agencies.

Unrefunded examinees of the cancelled 15 March 2020 CSE-PPT shall have a special application period from 14 to 21 December 2022 for purposes of taking the 26 March 2023 CSE-PPT.

Except for the CSE-FSO, the CSC shall issue separate examination announcements two (2) weeks before the start of each application period. The announcement shall contain detailed information on the following areas:

- a. Scope of examination:
- b. Passing grade;
- c. Testing centers;
- d. Qualification/Admission requirements;
- e. Application/Documentary requirements;
- f. Where to get the application form and how to file the application;
- g. Target release of test results; and
- h. Resulting civil service eligibility.
